### **IT IS HEREBY ORDERED:**

1. **THAT** the application is Certified Urgent for hearing Ex-Parte for the first instance
2. **THAT** this Honourable Court has hereby issued an Order staying the ex-parte Orders issued on 15th April 2021 in Nairobi Milimani Law Courts Chief Magistrate's Court Miscellaneous Criminal Application No. E1248 of 2021, Republic (Through the Office of the Attorney General) vs Kenya Tea Development Agency Holdings Limited, Kenya Tea Development Agency Management Services Limited, Chai Trading Company Limited and East African Tea Traders Limited pending the hearing and determination of this application inter partes and/or until further orders of the Honourable Court.
3. **THAT** this Honourable Court has hereby issued an Order restraining the Respondent by himself, his officers, servants, agents, Investigators, Inspectors or representatives otherwise howsoever from enforcing and/or continuing to enforce the ex parte Order issued on 15th April 2021 in Nairobi Milimani Law Courts Chief Magistrate's Court Miscellaneous Criminal Application No. E1248 of 2021, Republic (Through the Office of the Attorney General) vs Kenya Tea Development Agency Holdings Limited, Kenya Tea Development Agency Management Services Limited, Chai Trading Company Limited and East African Tea Traders Limited pending the hearing and determination of this Application, inter partes.
4. **THAT** this Honourable Court has hereby issued an Order restraining the Respondent by himself, his officers, servants, agents, Investigators, Inspectors or representatives otherwise howsoever from invading, ingressing, breaking into or remaining in the premises and places of operations of the Applicants herein that are located along Moi Avenue, KTDA Farmers House in Nairobi and in Miritini, Mombasa or any of its other offices within the Republic of Kenya and taking possession of the Applicants' properties pending the hearing and determination of this application inter partes and/or until further orders of the Honourable Court.
5. **THAT** the interim orders should lapse after 14(fourteen ) days of today unless an order extending same is made by this court.



6. **THAT** let all the application be served upon all respondents and interested party for inter parties hearing.

7. **THAT** each party i.e Applicants, Respondents Interested Party to file and exchange submissions in support of /or opposition to the Notice of Motion dated 19th April 2021.

8. **THAT** this file be placed before **Hon.GITHUA** Judge for Direction as to hearing on 29th April 2021
